Sub.: Haj - 1433 (H) - 2012. Allotment of Haj Seats.

Your State / Union Territory Final Quota as on date is reflected in Annex-1.

Haj Committee of India is continuously in the process of uplifting wait-listed Pilgrims by granting them provisionally selected status **strictly in terms of serial order of their Waiting List** against the Haj seats fall vacant due to cancellation of provisionally selected / confirmed Pilgrims.

You are, as such, advised to :

- (a) give wide publicity to the list of now provisionally selected Cover numbers alongwith waiting list numbers in local newspaper / media etc.
- (b) Make all out efforts to communicate with the Pilgrims using all means of communications so that Pilgrims are confirmed in terms of serial order of their appearance in Waiting List.
- (c) approach all such wait-listed Pilgrims, who have now been granted provision selection status and advise them to submit the Original Valid International Passport alongwith recent Passport-size photographs and pay-in-slips for the entire Haj amount for **AZIZIYA** Category etc. positively within next 2-3 days from the date of their selection.

Please notify to each now selected Pilgrim that due to shortage of **GREEN** category units, **all these Pilgrims will be allotted AZIZIYA category only** irrespective of the category they have opted for. The Pilgrims may be advised to remit entire Haj amount (Advance + Balance) (in terms of **AZIZIYA** Accommodation Category) immediately upon their selection and forward the original remittance receipt of the entire Haj amount to this office soon after transaction.

The Haj Application Forms alongwith other documents viz. Original valid International Passport alongwith recent Passport-size Photograph and original Remittance Receipt of the full Foreign Exchange amount deposited by each such now provisionally selected Pilgrim must reach the office of Haj Committee of India on very urgent basis.

- (2) -

As you are already aware that the Hon'ble Supreme Court of India in the matter of Special Leave Petition (Civil No.28609 of 2011 with Special Leave Petition (Civil) Nos.33190-33217 of 2011) has directed that allocation against cancellations will only be from wait-listed applications on "*first cancelled seat to first wait-listed applicant*" basis and no fresh cover applicant (outside Qurrah) will be entertained.

However, to ensure that your State Quota is fully utilized, make all out efforts to communicate with the Pilgrims using all means of communications so that Pilgrims are confirmed in terms of serial order of their appearance in Waiting List as is indicated in the earlier para. You may go beyond the now provisionally selected Pilgrims from the Waiting List in the event of some Pilgrims appearing at the top of the present waiting list order not ready to go for Haj - 2012 and may skip their order of waiting list so as to accommodate the next available wait-listed Pilgrim. However, you should furnish a statement in the following proforma justifying the skipping of wait-list number, if there is any.


