
Sub: Haj-2012. Allotment of Quota.

The Supreme Court of India in SLP No.28609 of 2011 about the 400 seats of Mehram Case has issued an order on 10.09.2012 to allot those 400 seats in the wait listed category.

As per order of the Hon'ble Supreme Court, the quota of these 400 seats has been distributed amongst the 19 States as per proportion of the Muslim population of the States. A state-wise statement of distribution of these 400 seats is enclosed herewith. Accordingly, waiting list applicants have been uplifted as per serial number and granted provisional selection.

You are advised to approach all such wait listed Pilgrims who have now been granted provisional selection status and advise them to submit Original Valid International Passport alongwith recent passport size photographs and pay-in-slip for the entire Haj amount of AZIZIYA category etc. on or before 28.09.2012.
