

Sub : Revised Quota for Haj-2013.

As per the information received from Government of Saudi Arabia, reduction of 20% in quota has been imposed on foreign pilgrims. Accordingly, 3605 seats have been reduced from the quota allocated to Haj Committee of India by Ministry of External Affairs. After, reduction of 3605 seats from the original quota, the state wise revised quota is as per the attached chart.
