Sub : Haj-2013: Advance receipt of International Passport
in respect of wait listed pilgrims.

As per circular No.24, state wise Revised Quota has already been intimated. Thereafter, the vacancies arising due to cancellations have also been utilized by upliftment of waiting list in serial order of your state vide circular No.25.

2. Further vacancies arising due to cancellation are also to be utilized by upliftment of waiting list in serial order of your state as indicated in **column No. 6** of **Annexure-I**. These provisionally selected pilgrims from the waiting list will have to deposit their entire amount (Advance amount + Balance Haj Amount) as per Aziziya category through core banking system against their bank reference number in account “**FEE TYPE-25**”. Pilgrims may also be advised that after depositing the amount in the bank, pay-in-slips and original passport should be submitted in their respective State Haj Committee on or before **7th September, 2013**.

3. As it is expected that there will be more cancellations, you are advised to approach the wait listed pilgrims at serial numbers shown in **column No.7** of **Annexure-I** and inform them to submit Original valid international Passport alongwith recent passport size photograph and the **undertaking of Annexure-II** immediately.

4. These documents may be kept ready in your office and may be submitted to this office as and when these pilgrims are given provisional selection status. They may be asked to deposit the requisite amount only thereafter and submit pay-in-slip to Haj Committee of India.
