Sub : Data Entry and Qurrah for Haj-2014

As you are aware, the last date of receiving of HAF i.e. 22nd March, 2014 is over. It is to be ensured that no HAF with pay-in-slip or passport issued after 22.03.2014 is entered in the IHPMS data base.

2. In continuation to this office's earlier letter No.HC-15/66/2014/3342 dated 24th January, 2014, every State/UT Haj Committee should strictly adhere to the dates of Data Entry, verification, editing, certification & qurrah for 2014 as per the schedule enclosed **annexure – I**. Entire task as per the schedule may kindly be completed and delay avoided in any process.
3. State/UT Haj Committee have to send a certificate as per the proforma enclosed **annexure – II** two days prior to qurrah in their respective state.
4. The infrastructure required at the venue of Qurrah is as under:-
 - (i) One (1)MPBS internet connectivity with back up line,
 - (ii) Two Computer systems,
 - (iii) One Laser Printer,
 - (iv) One LCD Projector with Screen,
 - (v) One UPS.
5. It may be noted that a demo shall be arranged by this office a day prior to qurrah for the users who shall conduct the qurrah. Final qurrah shall be conducted on supervisor login, allowed on the day of qurrah.
