

**Sub:** - Up-liftment of waitlisted pilgrims.

A statement showing the wait listed pilgrims for Haj – 2015 who are now provisionally selected against cancellation, is annexed.

2. The aforesaid pilgrims have to deposit the Haj amount as per their category of accommodation and embarkation point. The pilgrims may be advised that after depositing the entire amount in the bank, pay-in-slips and original valid machine readable international passport with one photograph attached to the back of passport with adhesive tape should be submitted in their respective State Haj Committees on or before 14<sup>th</sup> August, 2015 failing which the provisionally selection shall be treated cancelled.

3. The Haj applications, passports and pay-in-slips may be submitted by S.H.C to this office by 18<sup>th</sup> August, 2015, positively.
