Subject : Release of Waiting List for Haj – 2017.


In continuation to this office Circular No. 27, dated 20th July, 2017, further **1035** seats have become available due to cancellations received from various States out of which **453** seats are from under-quota States and cancellations of Lap-1 States (proceeding from India to Madinah Munawwarah). A statement showing cancellations received from the respective States and the wait-listed pilgrims for Haj–2017, who are now provisionally selected in terms of Guidelines for Haj – 2017, distributed as per Muslim Population are annexed.

2. The aforesaid provisionally selected pilgrims have to deposit the Haj Amount as per Aziziya category of accommodation and Embarkation Point :

- Online at hajcommittee.gov.in or
- In Haj Committee of India's Account No.32175020010 FEE TYPE-25 maintained with SBI or account No.318702010406009 (Haj Account) maintained with UBI through any branch of SBI/UBI having Core Banking System.

3. These provisionally selected pilgrims may be advised that after depositing the amount, original Valid Machine Readable International Passport with one colour photograph attached to the back of the Passport with adhesive tape, pay-in-slip of the deposited amount alongwith Medical Screening and Fitness Certificate etc. should be submitted to their respective State Haj Committee on or before **11th August, 2017**. Respective SHCs shall collect these documents in the serial order of waiting list alongwith Undertaking and a statement in the proforma (copies Annexed) justifying skipping of waiting list number. The skipping list should be duly certified by the Executive Officer of respective State / UT Haj Committee. The State Haj Committee shall submit these documents to Haj Committee of India immediately without any delay. **The State Haj Committee shall also intimate the now uplifted wait-listed pilgrims that in case of non-availability of seats in the flights of respective Embarkation Points, these newly selected pilgrims shall compulsorily be required to proceed for Haj from Mumbai Embarkation Point.**

4. The selection from waiting list shall be purely provisional and subject to Visa endorsement by Royal Consulate of Saudi Arabia, Mumbai failing which, Haj Committee of India will be constrained to cancel the provisional selection.
