In States/UTs where the quota is less than the number of applicants for Haj, selection of Haj pilgrims is done by computerized draw of lots (Qurrah). While the process of Qurrah is carried out on the IHPMS software on Central Server of Haj Committee of India, the display of selection is organized by respective State/UT Haj Committees.

2. For Haj 2018, all States/UTs were asked to fix the dates for Qurrah within the period of 11 to 23 January 2018. All States/UTs where the applicants were more than their quotas have completed the Qurrah as per schedule, except Kerala.

3. Kerala, States Haj Committee asked for Qurrah date to be held on 02.02.2018. It was pointed out by this office that postponement to such a late would cause inconvenience to the provisionally selected pilgrims as they will be left with no time to make payments as per Action Plan for Haj - 2018. Further the connected activities of Haj Committee of India would also be unduly delayed as the numbers of pilgrims in various categories and Embarkation Points cannot be finalized unless all pilgrims are selected. However, Kerala State Haj Committee did not agree to fix the Qurrah within the schedule time.

4. Accordingly, it was decided to conduct the Qurrah for selection of pilgrims of Kerala State on 23.01.2018 at 4.00 p.m in this office with due intimation to Kerala State Haj Committee. The details of Haj Application Forms received in different categories and quota allotted to Kerala States is given in Annexure - 'A'. The Qurrah was conducted State wise as per past practice. The SMS of selection have been sent to the head of the selected covers. Pilgrims can check their status directly from Haj Committee of India's website hajcommittee.gov.in
