Sub: Haj 2025 (Hijri 1446) - Deposit of Advance Haj Amount.

As per para 19 of the Guidelines for Haj 2025 (Hijri 1446), all the provisionally selected pilgrims are required to deposit initially Advance Haj Amount of **Rs.1,28,000/-**, non-refundable processing fee of **Rs.300/-** and Miscellaneous Dues of **Rs.2,000/-**. The consolidated Advance Haj Amount is to be deposited now by all the Provisionally selected pilgrim @ **Rs.1,30,300/-** per pilgrim from **08.10.2024 to 21.10.2024**.

- 2. The Payment of Rs.1,30,300/- can be made either,
 - a. E-payment facility available on https://hajcommittee.gov.in & "Haj Suvidha App"
 - (i) Credit Card
 - (ii) Debit Card
 - (iii) Net Banking
 - (iv) UPI
 - b. Amount can be deposited in any branch of either SBI or UBI in the account of Haj Committee of India through the specified Pay-in-Slip by using Bank Reference Number available on website against your cover number.
- 3. Other instalments will be decided taking into consideration the finalization of Airfare amount & Saudi expenses in Saudi Arabia and same will be intimated shortly. The details of expenditure for Haj-2025 for respective Embarkation Points will also be displayed on website i.e. hajcommittee.gov.in & "Haj Suvidha App".
- 4. The unique **Bank Reference Number** provided to each Cover must be mentioned in the Deposit Receipt.

- 5. After depositing the Advance Haj Amount, the Provisionally Selected pilgrims shall submit the following documents to concerned State/UT Haj Committees on or before <u>23.10.2024</u>
- a) Haj Application Form (HAF).
- b) Solemn Declaration & Undertaking.
- c) A copy of the pay-in-slip/ online receipt.
- d) Medical Screening and Fitness Certificate (as per format available on the website i.e. <u>hajcommittee.gov.in</u>).
- e) Self-attested copy of International Machine-readable passport.

It is hereby requested that the pilgrims must strictly adhere to the stipulated last date for deposit of Advance Haj Amount and submission of documents in the concerned State Haj Committee failing which their Haj seat shall be cancelled.
