**NOTICE**

Subject: Selected HGOs of Category-1\* Lead for Haj 2027 – regarding.

This Division had earlier published the list of eligible Category-1\* (Lead) Haj Group Organisers (HGOs) for Haj 2027 vide Notice dated 06.08.2026.

2. Subsequently, as per HGO Policy, representations/grievances were received from HGO applicants against the decision of the Scrutiny Committee. The representations were considered by the Apex Committee, constituted vide Ministry's Office Memorandum dated 09.07.2026, in accordance with its prescribed Terms of Reference.

3. After consideration of the representations, the Apex Committee recommended that M/s Alhind Tours & Travels Pvt. Ltd. and M/s Al-Hira Tours & Travels be included as Category-1\* (Lead) HGOs in place of M/s Harmain Tours & Travels and M/s El Burq Travels, respectively, on the basis of the comparative particulars, as per clause 4.2 of HGO Policy.

4. Accordingly, after considering the recommendations of the Apex Committee, the following 26 HGOs are hereby declared as Category-1\* (Lead) HGOs for Haj 2027 by the Competent Authority in line with HGO Policy for Haj 2027:
