1. Eligible agencies may visit/inspect the site on any working day between 10 AM to 5 PM by contacting the Haj House Section In-charge for inspection.
2. The interested agencies should upload completed Bid documents duly signed and stamped on each page along with scanned copies of all relevant certificates, documents, etc. in support of their technical and price bids.
3. **Performance Security Deposit:** - The successful Bidder will have to deposit a Performance Security Deposit i.e. 05% of the cost of the BID Value in the form of Bank Guarantee/Demand Draft/fixed bank deposit of a scheduled commercial bank in favour of **Haj Committee of India valid for 14 months** from date of commencement of work and in case of extension, further renewable on the same basis and without accrual of interest.

A. ELIGIBILITY CRITERIA

1. The bidder should be a company/ firm engaged in Comprehensive AMC services to 06 No's lifts installed in the premises of Haj Committee of India, Haj House, Mumbai -400001 during the period for one year.
2. OEM / Vendor (Authorization certificate) for the AMC work
3. The bidder must have at least (3) three years' experience (ending month of December prior to the bid opening) of providing AMC / CMC maintenance of the lift.
4. The bidder must have successfully executed /completed similar services over the last three years i.e. current financial year and the last two financial years: - (performance certificate)
 - a. One similar works of value not less than rupees **20 lakh** or
 - b. Two similar works of value not less than rupees **10 Lakh each**, or
 - c. Three similar works of value not less than rupees **7 lakh** each.
5. The bidder must be registered with active GST.
6. The bidder must be registered with ESIC & EPFO, if applicable. In case the registration with ESIC & EPFO is not applicable a self-declaration certificate may be furnished at the time of execution of agreement.
7. The bidder must have a valid PAN Number.
8. Minimum Average annual financial turnover of related services during the last three years i.e. 2022-23, 2023-24 and 2024-2025, ending 31st March of the previous financial year, should be **24 Lakhs**.
9. Firm should not be blacklisted by any Govt. department / PSU in last Three years. (duly signed copy required).
10. The bidder should have a registered/ branch office in Mumbai
11. MSME and Start Up will be given exemption for **Turnover** only. Being specialized service, no exemption will be given w.r.t. experience criteria.

B. INSTRUCTIONS TO BIDDERS

1. The Technical Bid should be accompanied by a **BID SECURITY DECLARATION on Company / agency letterhead** in the annexed format. **(See Annexure G.)**
2. The bidders shall quote for all work failing which the bid shall be considered non responsive.
3. Tender incomplete in any form will be rejected outright. Conditional Tenders will be rejected outright.
4. In case the successful Bidder declines the offer of Contract, for whatsoever reasons(s), action deemed fit will be taken as per tender terms and condition.
5. The formal contract shall be entered into with the successful Bidder. In what contract, the successful Bidder shall be defined as "Contractor", for purpose incidental to the agreement will be same as the contractor.
6. The successful Bidder will have to deposit a performance Security Deposit @ 5% of actual bid value by way of Fixed Deposit Receipt (FDR)/ DD/Banker's Cheque /e-PBG from a scheduled commercial bank and hypothecated in favour of "Haj Committee of India valid for 2 months beyond the expiry period of one year of contract and further renewable, if required. Alternatively, the Performance Security Deposit may be in the form of an unconditional Bank Guarantee from a scheduled bank in the format approved by HCoI of same validity as mentioned above.
7. The Successful Bidder will have to deposit the Performance Security Deposit and commence the work within 15 days of acceptance of tender, action deemed fit will be taken as per tender terms and condition.
8. All pages of tender documents uploaded should be numbered and signed by authorized signatory of participating firm with seal in acceptance of the terms & Conditions laid down by as per tender.
9. The Chief Executive Officer, Haj Committee of India reserves the right to reject/cancel all or any tender in whole, or in part, without assigning any reason thereof.
10. Agencies will have to submit an undertaking/declaration to the effect of bidder financial standing on the letter head of the agency in the Performa given at **Annexure-F.**

Scope of work:

1. The services shall be carried out as per CPWD general specifications for electrical works (Part-III), Lift & Escalator-2003 as amended up-to date.
2. Scope of services is comprehensive maintenance contract for one year. All materials/ spare parts etc. as mentioned in Annexure-A (inclusion in Comprehensive AMC), required for proper working condition is included in scope of services.
3. All T&P and special T&P shall be arranged by the agency (original equipment manufacturer) / Authorized agency & nothing extra shall be paid on this account.
4. All materials / spare parts etc. as mentioned in Annexure-A (inclusion in Comprehensive AMC) required at site during the maintenance shall be provided and replaced by the Authorized agency and no extra payment shall be made on this account.
5. Agency shall keep the lift clean. Sundry material such as dusting cloth, brush, detergent, Oil shall be provided by the agency Authorized agency at site within his quoted rates.
6. The complaints shall be attended by the Authorized agency at the earliest after the lodging of the complaint through phone/SMS/Email etc., but within the maximum time of 24 hrs after lodge of the complaint.
7. The Authorized agency shall strictly adhere to the maintenance schedule & replacement schedule etc. The Authorized agency shall depute trained supervisory staff for providing scheduled preventive maintenance/breakdowns, to make the lift run as safe operating condition.
8. The Authorized agency shall carry out maintenance and check of all items as laid down in the maintenance schedule. All maintenance checks shall be properly recorded by the maintenance staff of the agency in the prescribed maintenance register and duly counter verified by the HCoI.
9. The Authorized agency shall systematically examine various parts of the lift and the parts which need repair or replacement in the opinion of the HCoI shall be provided and replaced or repaired accordingly.
10. The required existing parts shall have to be replaced with the same make of the existing part or as recommended by the authorized agency.
11. Only skilled employees shall be deputed to carry out the repair, replacement and maintenance jobs.

12. If any complaint is lodged by HCoI through E-mail/Telephone for any defects in the lift, the defects shall have to be attended within 24 hours. In case of urgency, this shall have to be attended to even after the normal working hours without any extra claim.
13. The Engineer-in-charge shall keep up to date record for the comprehensive maintenance services done or attended to by the Authorized agency.
14. In case of any accident, (during the repair & maintenance by OEM for vendors employee) the whole responsibility shall be with the agency. No claim & whatsoever shall be entertained by the ESIC. All Employees of the agency should be insured. (Insurance Copy should be submitted to HCoI when entering into Contract).
15. In case, the Authorized agency stops the services in between or his services are discontinued due to unsatisfactory performance, the security deposit/ e-PBG shall be forfeited by the HCoI and other legal action may be taken by the HCoI as deemed fit.
16. Comprehensive maintenance covers parts mentioned in Annexure-A within the scope of services and nothing extra shall be paid by HCoI on this account.
17. After completion of the services, the agency shall handover the lifts in writing to the HCoI duly acknowledged by the Engineer-in-charge.
18. Preventive maintenance of lifts must be carried out every month with advance intimation to the Engineer-in-charge and report shall be submitted by the agency in their performa.
19. The agency will have to submit MOU signed with the Authorized agencies of manufacture, if manufacturer themselves is not willing to render comprehensive AMC services directly (If agency is non-OEM). The MOU in the enclosed form (Annexure —C of additional terms and conditions) shall be signed by both the parties' i.e. agency as 1st party and Authorized agency as 2nd party submit the same at the time of applying on the GeM portal.
20. **Penalty:** If the agency fails to attend the fault for more than 24 hours, then penalty of Rs. 500 per complain per day per lift would be imposed. The agency shall be required to rectify faults within a reasonable time frame and any procrastination shall not be permitted.
Such penalties shall be subject to 2% of cost per month per lift and maximum up to 5% of the contract value.
21. Periodically examining all safety devices and governors and make all customary safety tests.
22. "HCoI reserves its right to terminate the Comprehensive AMC contract at any time after giving one-month due notice without assigning any reason. The agency will not be entitled to claim any compensation against such termination. However, while terminating the contract, if any payment is due to the contractor for maintenance services already performed in terms of the contract, these would be paid to him as per the contract terms".
23. **Compliance with Statutes, Regulations:** The Contractor shall conform in all respects, including by the giving of all notices and assist, with the provision of:
 - a) Any National or State Statute, Ordinance, or other Law, or any regulation, or bye-law of any local or other duly constituted authority in relation to the execution and completion of the Works and the remedying of any defects therein, and

- b) The rules and regulations of all public bodies and companies whose property or rights are affected or may be affected in any way by the Works, and the Contractor shall keep the Employer indemnified against all penalties and liability of every kind for breach of any such provision.
- c) Any changes required for approval due to revision of the local laws.
24. **Payment terms:** - Payments shall be made on quarterly basis after satisfactory completion of service on receipt of tax invoice/bill complete in all respect duly signed for actual services performed as per scope of work mentioned in the contract. In case of any delay in payment, the work should not suffer. No interest shall be demanded for delayed payment, if any. The payment would be released according to procedure laid down in latest Central Government General Finance rules. All payment shall be released by Haj Committee of India, Haj House, 7-A, M.R.A. Marg (Palton Road), Mumbai – 40001 against half yearly bill submitted by and duly vetted by Incharge (Haj House), HCoI.
25. **Extension of Time of contract:** - The CAMC contract may be extended on the written mutual consent of both parties for a further period of one year or part thereof on the same terms & conditions of this contract. However HCoI reserve its right to terminate the CAMC Contract by giving One month notice at any time during the currency of the contract, if the service of the agency are not found satisfactory as per opinion of Engineer-In charge. In case of emergent situation prevalent in the country, this contract can be extend up to period of 03 month unilaterally.
26. **ARBITRATION CLAUSE:** It is mutually agreed that all differences and disputes arising out of or in connection with this Agreement shall be settled by mutual discussions and negotiations. If such disputes and differences cannot be settled and resolved by discussions and negotiations then the same shall be referred to the Sole Arbitrator appointed by the Chief Executive Officer, Haj Committee of India, Haj House, Mumbai, whose decision shall be final and binding on both the parties as per provision of arbitration and reconciliation Act 1996. Further, disputes are subject to settlement at courts hearing jurisdiction at Mumbai only.

General Terms and Conditions

- The HCoI shall not be liable for in respect of any damages or compensation payable to any workman for death or injury resulting from any act or default of contractor.
- Agency has to attend the unlimited number of breakdowns since these lifts are catering to the Hospital services which come under the purview of emergency services.
- All the equipments / installations shall always be kept in good and trouble-free operating conditions.
- If for any reason any equipment is required to be repaired from any outside agency or in any workshop, the same will be arranged by contractor at their own cost within the quoted prices.
- In case the contractor fails to commence the contract by the date mentioned in the work order, the performance security deposit shall be forfeited and the contractor shall be blacklisted for One year.

- Agency shall check & rectify all parameter of lift in every month and submit the report to the hospital accordingly besides attending to all breakdown calls as and when warranted.
- The name and contact number of the authorized personnel should be provided who are to be contacted in case of any breakdown.
- The preventive/breakdown servicing report is to be submitted to the Engineer-in-charge for any breakdown.
- The corrective/break-down maintenance is to be carried out anytime during 24 hrs per days inclusive of all Sundays & Holidays.
- The scope of work in CAMC may be increased or decreased, i.e., the number of lifts may be adjusted as decided by the competent authority of HCoI. The value of lifts will be determined based on their capacity, and the terms and conditions will remain the same as outlined in this agreement. Other lift-related work not covered under CAMC may be assigned accordingly.

Inclusion in Comprehensive AMC

1. **Repair /Replacement of parts:** Authorized agency at its option may go for repair or replacement of any defective parts. Defective parts will be furnished by the Authorized agency on an exchange basis under which the replaced parts become the property of the Authorized agency. However, the Authorized agency will not make any replacements / renewals / repairs necessitated by any obsolete or disconnected parts of the units or by reason of any cause beyond control of agency (except ordinary wear and tear) including but not limited to fire, explosion, theft, floods, water, weather, earthquake, vandalism, misuse, civil works, improper earthing, improper power supply or repairs by others.
2. Renew all wire ropes and chains (where fitted) as often as required to maintain an adequate factor of safety, to equalize the tension on all hoisting ropes, repair or replace conductor cables and hoist way and machine room elevator wiring.
3. Systematically examine and adjust the following components: Machine & its subassemblies, Motor & Windings, encoder, Worm Gears & shaft, Bearings, Main & deflector, secondary Sheaves, Brake coils, liners and related assembly, Ropes or Coated Steel Belts (CSB) & associated parts including spring/rubber/thimble, Controller parts- Circuit breakers, fuses, Connectors, switches, Relays & Contacts, VF Drive & braking unit.
4. Automatic Rescue device parts like printed circuit board, transformers, circuit breakers, contactor relays, Cabin Safety Mechanism and Cabin bottom Platform.
5. Selector system subassemblies like Levelling Devices, Cams, Relays, Rectifiers, Transformers, Contacts, Leads, Dashpots, Timing Devices, Steel Select or Tapes and Mechanical and Electrical Driving Equipment.
6. Governor, Governor Sheave, Shaft Assembly, Bearings, Contacts and Governor Jaws; Governor Tension Sheave Assembly or Car and Hall push Buttons, Car and Hall Position Indicators, 7 or 16 Segment displays or TFT & Small Monochrome displays Hall Lanterns bulbs or PCB's, Car Direction Indicators and all other Car and Landing Signal Fixtures.
7. Intercom installed by the Thyssenkrup / Otis cabin lights, emergency light and alarm unit including battery, Emergency & Inspection control panel parts like PCB's circuit breakers, Fireman switch excluding the glass, Car and Counterweight—Sheaves, Bearings, Car and Counterweight Guide Rails and Buffers, brackets, Stop switches, Counterweight Guide shoes including Roller or Liner, Top and Bottom Limit Switches, Stop switches, Compensating Sheave, compensation ropes/chains, Position reference system door zone sensors/Magnets/vanes, Load Weighing sensors.
8. Interlocks on Landing Door, Car & Landing Door Hangers, Guides, Automatic Power Operated Door Operator including VF drive, Car Door Contact, Mechanical Safety Shoe, 2D electronic door sensor.
9. Dead load test will be carried out by subjecting the equipment to maximum dead load for half an hour. The equipment should retain this load for the specified period without signs of permanent distortion. All arrangements (including necessary testing instruments shall be provided by the tenderer without extra cost). Test to determine that the motor, break, control equipment and door

locking devices and limit switches function correctly. Break shall be tested to check whether it can sustain a case at rest with contracted load plus 25% additional load. The periodicity of the test shall be once in a year from the date of commencement of contract.

10. The old and retrieved material will be the property of HCoI during the period of contract, as this is a comprehensive service contract.

11. Inspection report for the tests carried out in the presence of HCoI in charge shall be submitted to HCoI duly signed by the contractor or his authorized representative.

5. Service reports / logbooks maintained for the said services shall be signed by the service provider as well as by the agency itself.
6. All the correspondence regarding providing Comprehensive AMC services shall be done by the HCoI with the service provider with a copy to agency. In case of non-compliance of the provisions of agreement, the agency, as well as service Provider shall be responsible. The action under clauses 2 and 3 shall be initiated and taken against the agency.
